Executive Director's Report – Bruce Buckles shared that the state is looking at a 15% cut. Impacts to 6,300 In-Home clients and 3,000 residential clients. 70 FTE positions between AAA's and HCS. ALTSA has already participated in furloughs, etc. Many services around the state either cut or eliminated. Presently our agency is strong and has met challenges in COVID-19. Agency will continue to host the Incident Command Center for another 30 days and host 6 epidemiologists.
